

FAQ: Tuition Refund Policy for MD Students

Below are some frequently asked questions to guide you through the <u>Tuition and Fees Refund Policy</u> for medical school students. Please reach out to the Student Affairs Office or your Associate or Assistant Dean for Student Affairs if you have any questions about the policy or this FAQ.

Q: Will I receive a refund if I completely withdraw from medical school?

A: You are eligible for a refund if you withdraw by a certain date. The refund deadline varies each semester, so please refer to the current <u>Academic Calendar</u> for specific dates.

If you have completed two (2) or more units of credit in the semester, no refund will be granted. If you complete one (1) unit of credit and drop all remaining courses by the refund drop date, you may be eligible for a partial refund.

Q: What is the deadline to receive a full refund?

A: A 100% refund is available if you withdraw by the published refund drop date of your first enrolled class for the semester. This date is calculated using the formula provided by the University Registrar.

For specific dates, please refer to the current <u>Academic Calendar</u> or the University of Arizona Office of the Registrar's non-standard dates and deadlines calendar.

Q: Does the COM-T have a prorated tuition refund option?

A: The College of Medicine – Tucson does not generally offer a prorated tuition refund. However, in semesters that begin with a 1-unit course, a prorated tuition refund may be possible. For example, in Semester 1, "Orientation Week" (also known as "Introduction to the Profession") is a one-unit course. Similarly, in the fourth year, students may enroll in 1-unit electives. If a student completes only one of these 1-unit courses and then withdraws completely from UACOM-T, they will be billed for that specific 1-unit course. However, they may qualify for a prorated refund if they drop all their remaining courses by the drop date for that semester.

Q: How can I find the withdrawal/refund deadlines?

A: The dates are provided for our medical students in our <u>Academic Calendars.</u>

In addition, you can review these dates on the University Registrar website.

To locate the withdrawal/refund deadline, follow these three steps on the UArizona Office of the Registrar Dates and Deadlines Calendar website (<u>https://registrar.arizona.edu/dates-and-deadlines</u>):

- 1. Select "Non-Standard Class Dates" as your calendar type.
- 2. Select the Term you are withdrawing.
- 3. Select 'Medical School' in the Career field.
- Select the class information which generally follows the format MEDI 801-001 Subject (MEDI) Course (801) Section (001)
